- 8. The construction of boiler shall confirm to Indian Boiler Regulation 1950 and amendment.
- 9. The construction of boiler shall be certified by the Inspecting Authority (Chief Inspector of Boiler of the manufacturing State)
- 10. The undersigned reserves the right to accept or reject any or all the tenders without assigning any reason thereof.

Sealed tenders/quotations are invited from reputed Manufacturer/ Authorized Supplier for supplying of reputed make Boiler machines with Chimney for installation of the same at our Dye House of Sambalpuri Bastralaya HLCS Ltd., Bargarh.

- 1. The works shall have to be executed within 60 days from the date of placing orders. Only those tenderers who have the necessary expertise to execute the job within the stipulated time should submit the tenders on the above address. He/they shall have to pay 10,000/- (Rupees Ten thousand) only per day for any delay made for completion of the work after the stipulated period.
- 2. In case, any portion of installation work is not completed as per laid down specifications and handed over the same to the authority before the due date, penalty of 1% on the total value of work allotted/awarded will be imposed per day by the undersigned.
- 3. The Supplier will be responsible for up keep and maintenance of the entire installation work done by him including trial running, for which, no extra payments shall be made. He shall therefore, have to ensure for proper delivery of the products to be installed in this unit to the satisfaction of the undersigned. Any breakages and /or damages to any part shall immediately be settled without any extra payment caused on account of whatsoever reason or natural calamities.
- 4. All the tenderers should fill the rate tendered in figures as well as in words. The tender form may be filled in English and all entries made by hand and written in ink. Over writings in rate is not permitted. All corrections should be attested by the tenderers with his initials as many times as corrections occur. Each page of the Tender Form and other related papers submitted there-with should be signed by the tenderers. Any discrepancy in the rates written in figures and words, then the rates written in word is final. Similarly discrepancy in the rates quoted for unit rate and total amount, then the rate quoted for unit is final.
- 5. No advance will be paid for supply of Boiler. But 70% of the cost of machinery shall be paid after delivery of the machineries to the site of Sambalpuri Bastralaya and rest 30% shall be made after installation, commissioning of the Boiler alongwith replacement of steam pipeline & erection of chimney.

6. Earnest Money Deposit (EMD)

6.1. Tenderer shall pay Earnest Money Deposit (EMD) at rate of 2% of quoted value in favour of Sambalpuri Bastralaya HLCS Ltd., payable at Bargarh.



- 6.2. The EMD of unsuccessful tenderer will be refunded to them within 30 days from the date of decision regarding acceptance of the tender.
- 6.3. EMD deposit will be forfeited /encased in the following circumstances
- a) If a bidder withdraws his bid during the period of validity specified or makes any modifications in terms and conditions of the tender before the said period
- b) If the successful bidder fails within the time limit to sign the contract/agreement or fails to furnish the required security deposit.
- 7. While submitting the tender, the tenderers should submit the following:
 - a. Authentic proof of the supply made to any reputed organization of similar nature and value with any Govt. /Reputed institutions etc in a single work order and its certificates etc.
 - b. Pan No. /Income Tax Return (last year)/GST clearance certificate/TIN etc as required for the Tender process.
